RESOLUTION NO. 2014-17

LEVYING FOR THE YEAR 2015 AN ANNUAL TOWNSHIP TAX AT THE RATE OF 3.0 MILLS UPON ALL REAL PROPERTY WITHIN EAST COVENTRY TOWNSHIP MADE TAXABLE FOR GENERAL TOWNSHIP PURPOSES AND 0.012 MILL UPON ALL REAL PROPERTY WITHIN 780 FEET OF A WATER FIRE HYDRANT WITHIN EAST COVENTRY TOWNSHIP.

WHEREAS, the Board of Supervisors of East Coventry Township, pursuant to Section 3205 of The Second Class Township Code, 53 P.S. §68205, may, by resolution, levy an annual Township tax upon real property within the Township made taxable for general Township purposes and pursuant to Section 1802 of The Second Class Township Code assess the cost of maintaining fire hydrants and fire hydrant water service for the purposes of fire protection, as ascertained by the past adjusted valuation for Chester County purposes; and

and WHEREAS, said annual Township tax for general Township purposes at a rate of 3.0 mills, was levied in the year 2014;


WHEREAS, the Board of Supervisors of East Coventry Township, for the year 2015, has decided to maintain the tax for general township purposes at 3.0 mills and to levy an assessment, pursuant to Section 1802 (1) of the Second Class Township Code in the amount of 0.012 mills, to maintain fire hydrants and fire hydrant water service.

NOW, THEREFORE, BE IT AND IT IS HERBY RESOLVED, by the Board of Supervisors of the Township of East Coventry, Chester County, Pennsylvania, that an annual Township tax, at the rate of 3.0 mills, be and is hereby levied for the year 2015 upon all real property within East Coventry Township made taxable for general Township purposes, as ascertained by the last adjusted valuation for Chester County purposes, said rate being equal to a rate of taxation of thirty cents (\$0.30) on each one hundred dollars (\$100.00) of assessed valuation of such property, and

An assessment at the rate of 0.012 mills, be and is hereby levied for the year 2015 upon all real property within East Coventry Township made taxable for general Township purposes, as ascertained by the last adjusted valuation for Chester County purposes that are within 780 feet of a fire hydrant, said rate being equal to a rate of taxation of one and two tenths cent (\$0.012) on each one hundred dollars (\$100.00) of assessed valuation of such property, and


