RESOLUTION NO. 2015-09**

**A RESOLUTION ESTABLISHING COMPENSATION
FOR MEMBERS OF THE EAST COVENTRY TOWNSHIP
ZONING HEARING BOARD FUNDED FROM HEARING FEES**

WHEREAS, Section 907 of the Pennsylvania Municipalities Planning Code (53 P.S. §10907) and Section 1504.2 of the Zoning Ordinance of East Coventry Township (the “Township”) authorize the Board of Supervisors of the Township (the “Board of Supervisors”) to fix the compensation of members of the Zoning Hearing Board for the performance of their duties, provided such compensation shall not exceed the rate of compensation authorized to be paid to the members of the Board of Supervisors; and

WHEREAS, Section 908(1.1) of the Pennsylvania Municipalities Planning Code (53 P.S. §10908(1.1)) and Section 1504.4 of the Zoning Ordinance of the Township authorize the Board of Supervisors to prescribe reasonable fees for hearings before the Zoning Hearing Board, which fees may include compensation for, among other things, the members of the Zoning Hearing Board; and

WHEREAS, the Board of Supervisors desires by this Resolution to establish that compensation be paid to members of the Zoning Hearing Board on the terms and conditions hereinafter provided.

NOW, THEREFORE, BE IT AND IT IS HEREBY RESOLVED by the Board of Supervisors of East Coventry Township, Chester County, Pennsylvania, as follows:

SECTION 1. Zoning Hearing Board Hearing Fee.

A. A hearing fee to compensate members of the Zoning Hearing Board is hereby established at the rate of Twenty-Five Dollars (\$25.00) per member, per hearing and Twenty-Five

Dollars (\$25.00) per member, per hearing continuance. Each Application to the Zoning Hearing Board shall constitute a separate hearing, even in the event two or more applications are heard on the same day.

B. The hearing fees for compensation of members of the Zoning Hearing Board shall be deducted from the Application Fee paid and received by Township at the time the Application is submitted and deemed complete.

C. The hearing fee shall be paid by the Township to the members of the Zoning Hearing Board as compensation for the performance of their duties.


D. Hearing continuances shall be scheduled in such a manner so as to ensure that the compensation paid to members of the Zoning Hearing Board shall not at any time exceed the monthly compensation payable to members of the Board of Supervisors.

SECTION 2. Effective Date. This Resolution shall take effect immediately upon adoption.

SECTION 3. Repealer. All prior ordinances and resolutions, or parts thereof, to the extent that they are inconsistent with this Resolution are hereby vacated, rescinded and repealed.


