**RESOLUTION NO. 2019-15**

**RESOLUTION RATIFYING THE CREATION OF  
THE EAST COVENTRY TOWNSHIP  
AGRICULTURAL SECURITY AREA ADVISORY  
COMMITTEE AND APPOINTING MEMBERS TO  
SERVE ON THE COMMITTEE.**

**WHEREAS**, the Agricultural Area Security Law, 3 P.S. §901, *et seq.*, authorizes the Township of East Coventry to establish an Agricultural Security Area Advisory Committee (“ASA Advisory Committee”) by resolution of the Board of Supervisors; and

**WHEREAS**, the Agricultural Area Security Law requires that the membership of the ASA Advisory Committee consist of three active farmers, each representing a different private or corporate farm, one resident of East Coventry Township, and one member of the East Coventry Township Board of Supervisors, who shall serve as the ASA Advisory Committee’s chairman; and

**WHEREAS**, the Board of Supervisors of East Coventry Township previously established an ASA Advisory Committee and desires to ratify and confirm the establishment of said ASA Advisory Committee; and

**WHEREAS**, the Board of Supervisors of East Coventry Township desires to appoint several qualified residents of East Coventry Township to serve as the current members of the ASA Advisory Committee.

**NOW, THEREFORE, BE IT AND IT IS HEREBY RESOLVED**, by the Board of Supervisors of East Coventry Township, Chester County, Pennsylvania, as follows:

1. The establishment of the ASA Advisory Committee for East Coventry Township is hereby ratified and confirmed in all respects.
2. The following individuals are hereby appointed to serve as the current members of the East Coventry Township ASA Advisory Committee:
  - i. Michael Moyer - Member, Board of Supervisors

- ii. Robert Preston - East Coventry Township Resident
- iii. Leroy Kolb - Farmer
- iv. Arthur Kulp - Farmer
- v. Roger Kolb - Farmer

- 3. The foregoing appointments shall take effect immediately upon adoption of this Resolution.
- 4. The members of the ASA Advisory Committee shall serve at the pleasure of the Board of Supervisors.
